As a Year 12 student, you can apply to both the CMS Law Scholarship and / or CMS Connect.

Please note that the programmes have slightly different eligibility criteria, application processes and deadlines. Notably, if you are applying to the CMS Law Scholarship programme, you must submit a written essay.

Law Scholarships Who can apply?

- You're in Year 12 in England & Wales or Year 13 in Northern Ireland
- You attend a state-funded school, sixth form or further education college
- Your parents and grandparents did not attend university
- You intend to apply to study at university through the 2024/2025 UCAS process
- You are passionate about pursuing a career in law
- You have not been convicted of a criminal offence
- You are not related to any partner of CMS
- You also meet one of the following criteria:
 - You are, or have been at any time between ages 11 and 16, eligible for free school meals. (Or would be eligible if you attended a School Sixth Form.)
 - Your school from years 7–11 has 20% or more students eligible for free school meals.
 - · You are, or have been, a child looked after/care experienced
 - Your home address is in POLAR4 quintile 1 (i)
- (i) Check your postcode for eligibility



Law Scholarships How do I apply?

To be considered for a scholarship, you will need to enter our essaywriting competition which closes 12 July 2024.

The essay questions to choose from this year are:

1. "Anyone should be allowed to buy vapes if they want." Do you agree?

2. Should countries be able to strip someone of their citizenship?

Essays must be between 750 and 1000 words.

CMS Connect Who can apply?



- . You're in year 12
 - At a state school
- You must also meet one or more of the following:
 - You are currently in receipt of, or have previously received, free school meals, Pupil Premium, Education Maintenance Allowance and/or 16 to 19 Bursary
 - You grew up in a household where no parent or guardian attended university
- You have been, or are currently, in local authority care (for a period of 3 months or longer)
- You are, or have been, a full-time or part-time carer
- You came to the UK as a refugee or asylum seeker
- You are attending a state school or college with:
 - a) below average A-Level or Higher point score and/or
 - b) low rate of progression to higher education.
 - (PRIME Work Experience School Eligibility Criteria)

Note: young people who meet the local authority care criterion do not need to meet any other criterion.

Applications open 24 April and close 19 June

Complete the below questions (maximum 200 words each):

- 1. Please tell us about your proudest achievement. This could be from any aspect of your life (e.g. it doesn't have to be an academic achievement).
- 2. What motivated you to apply to CMS and what do you hope to gain from this experience?

Application hints and tips



Your application

- Don't leave your application until the last minute.
- Ask your friends, family and teachers to proof read it for you.
- Check for typos and grammatical errors – attention to detail is vital for lawyers.
- Use all of the available word limit.

Law Scholarship essay

- Think around the question and look for angles that are not obvious – a different take will make you stand out.
- Lawyers don't sit on the fence

 so reach a reasoned
 conclusion.
- Don't use long words or pretentious language.
- Use research to find evidence to back up your arguments and give references for your evidence.

Motivational questions

- Research CMS and the type of law we do here. Hint: we are a commercial law firm! This shows you are enthusiastic, interested and motivated.
- Try to avoid cliches and make your answers personal to you
- Remember, Lawyers make a difference to the world in a variety of ways – not just human rights lawyers or defence counsel.
